## CERTIFICATE OF AMENDMENT TO THE BYLAWS OF FAIRWAY OAKS CONDOMINIUM ASSOCIATION, INC.

1. Article I, Section 1 of the Bylaws is amended as follows:

2. Article IV, Section 1 of the Bylaws is amended as follows:

Article IV, Section 1. Number, Term and Qualifications. The affairs of the Association shall be governed by a Board of Directors, serving without compensation, composed of not less than three (3) nor more than <u>five (5)</u> nine (9) directors. There shall never be less than 3 directors. ... (*Remainder of Section remains unchanged.*)
