AMENDMENT TO DECLARATION OF PROTECTIVE COVENANTS FOR MARSHALL'S LANDING

The Declaration of Protective Covenants for Marshall's Landing ("Declaration"), as recorded in Official Records Book 2232, at Page 5088, of the Public Records of Manatee County, Florida, are hereby modified, supplemented, and amended by the Declarant, TRB Development Braden River, LLC, a Florida limited liability company, as follows:

1. The following provision is hereby added to Section 9.11(a) ("Setbacks") of the Declaration:

Notwithstanding the above, terraces, viewing fences, patios, decks, and caged and/or uncaged swimming pools may be erected within the setback areas and private maintenance and drainage easement(s), provided that such construction: (1) does not encroach on any <u>public</u> easements denoted on the Plat(s) of this Subdivision; (2) in the opinion of the Architectural Review Committee, does not interfere with the exposure or view or reasonable privacy of adjoining or facing properties; (3) is otherwise approved by the Architectural Committee in its sole and absolute discretion; and (4) does not conflict with the Manatee County Land Development Code, or other applicable regulations.

2. Except as hereinabove modified, supplemented, and amended, the unaffected provisions of the Declaration shall remain in full force and effect.
