RECITALS

WHEREAS, Declarant is the "Declarant" under the Declaration of Covenants, Conditions and Restrictions of Lakewood Ranch Town Center recorded in Book 1524, Page 6099, Public Records of Manatee County, Florida, as amended by previous Amendments and various Supplemental Declarations adding or withdrawing Committed Property (collectively, the "Declaration"); and

WHEREAS, Pursuant to Article XIII, Section 4 of the Declaration, Declarant has the right to amend the Declaration, and wishes to do so as provided herein;

NOW, THEREFORE, the Declaration is hereby amended as follows:

- 1. Article VI, Section 1, Subsection (v) is amended by adding the following sentence to the end thereof:
 - No sign shall be held, waved, or twirled within the Committed Property or within the rights-of-way or public property adjacent to the Committed Property.
- 2. Article VI, Section 1 is amended by adding the following subsection to the end thereof:
 - (w) No portion of the Committed Property shall be used for any of the following uses:
 - 1. Pawn shops
 - 2. Any "adult" bookstore or establishment selling pornographic materials
 - 3. Tattoo parlor or any establishment providing tattoo services
 - 4. Payday lenders or check cashing services such as Amscot
 - 5. An establishment specializing in the sale of vaping products

3. Capitalized terms used in this Amendment but not defined herein shall have the respective meanings given to such terms as defined in the Declaration.
